

## SUMMARY ANNUAL REPORT

### For LAWRENCE UNIVERSITY OF WISCONSIN WELFARE BENEFIT PLAN

This is a summary of the annual report of the LAWRENCE UNIVERSITY OF WISCONSIN WELFARE BENEFIT PLAN, EIN 39-0806297, Plan No. 515, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

LAWRENCE UNIVERSITY OF WISCONSIN has committed itself to pay certain self-insured Medical and Dental claims incurred under the terms of the plan.

#### Insurance Information

The plan has contracts with SYMETRA LIFE INSURANCE COMPANY, CARE-PLUS DENTAL PLANS, INC., ERC, INC, and WYSSTA INSURANCE COMPANY INC to pay Dental, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$361,229.
